EXPOSURE CONTROLS/PERSONAL PROTECTION

**FIRST AID**

EYE CONTACT: Check for and remove any contact lenses. IMMEDIATELY flush Eyes with running water for at least 15 minutes while keeping eyes open. COLD water may be used. Seek medical attention.

SKIN CONTACT: After contact with skin, wash with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap.

ACCIDENTAL RELEASE MEASURES

Steps to be taken if material is released or spilled: Wear appropriate respirator, rubber boots and heavy rubber gloves. Scoop up and place in an appropriate container. Ventilate area and wash spill site after pickup is complete. Wash skin immediately with plenty of water. Absorb on sand or vermiculite and place in closed



containers for disposal.
